- The Board of Directors of the Company at its meeting held on September 07, 2020 has appointed me as Scrutinizer for the postal ballot voting process (which includes e-voting also) on the resolutions contained in the Notice dated September 22, 2020 issued pursuant to the Companies Act, 2013 and Rules made thereunder read with MCA Circulars dated April 8, 2020, April 13, 2020 and June 15, 2020.
- 2. The Management of the Company is responsible to ensure compliance with the requirements of the Act and rules relating to Postal Ballot including e-voting.
- 3. My responsibility as scrutinizer for the Postal Ballot including e-voting is restricted to making a Scrutinizer's Report of the votes cast in favour or against the resolution(s).
- 4. I submit my report as under:
 - a. The Company has informed me that it has completed on September 26, 2020 the dispatch of postal ballot notices and forms to its Members whose name(s) appeared on the Register of Members/list of beneficiaries as on September 18, 2020, the record date fixed for the purpose.
 - b. The Company has extended the facility of e-voting to the shareholders by tying up with the Link Intime India Private Limited ("LIIPL") e-voting facility.
 - c. The e-voting remained open for the period commencing from Thursday, 1st October, 2020 at 10.00 A.M to Friday, 30th October, 2020 at 5.00 P.M. (e-voting period).



d. After the completion of e-voting period, using the scrutinizer's login on the LIIPL evoting portal, the votes cast through remote e-voting were unblocked.
