Dear Shareholder,

Securities and Exchange Board of India vide Circular No. SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023 ("SEBI Circular"), has made it mandatory for the holders of physical securities to furnish Permanent Account Number (PAN), contact details (Postal address, Mobile Number & Email), bank account details, signatures and nomination. Folios wherein any of the above document(s)/details are not furnished on or before October 01, 2023, shall be frozen by the Registrar and Share Transfer Agent (STA) and you will not be eligible to lodge grievance or avail any service request from the STA till the aforesaid documents/details are submitted. Please also note that for any dividend payment in respect of such frozen folios will be made only through electronic mode with effect from April 01, 2024 upon submitting the aforesaid documents.

Further, the holders of physical securities are requested to ensure that their PAN is linked to Aadhaar to avoid freezing of folio by June 30, 2023 or any other date as may be specified by the Central Board of Direct Taxes to avoid freezing of your folio.

Please note that in case you already have a Demat Account singly or jointly with joint holder (s) (applicable in case of Joint Holders only) mentioned above, you may also send your Client Master List (CML) duly signed and stamped by the Depository Participant duly filled and signed Form ISR-1 and the STA shall update your folio with the information of 1) present address, 2) bank details, 3) E-mail address, and 4) mobile number, from the details available in the CML

The Shareholders may also note that with effect from 1 April 2019, the requests for effecting transfer of shares shall not be processed unless the shares are held in dematerialized form with a Depository. Hence, the shareholders holding shares in physical form are also requested to dematerialize their physical shares into electronic form by sending the demat request to their concerned DPs

Please also note, in case the shares in the frozen folios continue to remain frozen as on December 31, 2025, such shares shall be referred by STA/Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and / or Prevention of Money Laundering Act, 2002
