Drugs worth Rs 16 lakh seized, seven arrested in Mumbai. Pune

MUMBAI: The Anti-Narcotics Cell of Mumbai Police has arrested seven persons including two Nigerians from Mumbai and Pune and seized drugs worth Rs 16.14 lakh, an official said on Wednesday. As much as 58 grams of mephedrone and 15 grams of cocaine were seized during the operation, he said. The Ghatkopar unit of the ANC had received a tip-off about a fivemember gang involved in drug trafficking, the official said. The gang members included two women, one of whom lived with her son at Kemps Corner in South Mumbai while the other lived in Marve Road area in suburban Malad, the official said. One of the women frequently traveled from Dadar to Pune by taxi to supply drugs to clients there, he said.

Maha govt launches child-friendly squads as pilot project for Mumbai

MUMBAI: The Maharashtra government on Wednesday launched six squads tasked with rescuing street children in Mumbai and helping them rehabilitate under a pilot project. State Women and Child Development Minister Mangal Prabhat Lodha said the squads will be equipped with a van, a caretaker, a counsellor and a teacher. "These six squads will be mobile and visit various areas in Mumbai. They will work for rescuing street children, counselling them and admitting them to NGOs or local schools. They will ensure that these children get a good meal and help in their rehabilitation," Lodha told reporters. He said the government wants to bring the vagabond and street children into the mainstream and ensure they get a good education.

Evacuate immediately, Kejriwal urges people in low-lying areas as Yamuna swells to record level

PTI, NEW DELHI: The Yamuna in Delhi swelled to 208.05 metres on Wednesday, breaching its all-time record of 207.49 metres set 45 years ago, flooding many areas and prompting Chief Minister Arvind Kejriwal to appeal to people living in low-lying to evacuate immediately.

Thousands of people have been shifted to safer areas as water gushed into their homes and markets near the river, causing them immense hardships.

Waterlogging on parts of the busy Ring Road, including on the stretch between Majnu ka Tila and Wazirabad, led to traffic congestion, officials said.

In view of the grave situation, the Delhi Police improhibitory posed measures under CrPC section 144 in flood-prone areas of the city, preventing unlawful assembly of four or more people and public movement in groups.

Lt Governor V K Saxena has called a meeting of the Delhi Disaster Management Authority (DDMA) on Thursday over the rising water level of the Yamuna, Raj Niwas officials said.

SIX MORE DIE IN RAIN-RELATED INCIDENTS IN PUNJAB, HARYANA; TOLL CLIMBS TO 21

PTI, CHANDIGARH: Six more deaths due to rain-related incidents were reported in Punjab and Haryana on Wednesday, while authorities in the two states focused on relief operations as the weather cleared after days of heavy rains.

The death toll now stands at 21, including 10 in Haryana, according to government data. Overall, 14 districts have been affected in Punjab and seven in Haryana. About 14,000 people have been shifted to safer places from waterlogged localities in Punjab's Patiala, Rupnagar, Moga, Ludhiana, Mohali, SBS Nagar, Tarn Taran, Jalandhar and Fatehgarh Sahib districts over the last three days, authorities said. An official spokesperson said 1,058 villages in 14 districts of Punjab have been affected by the floods. Chief Minister Bhagwant Mann said he is getting regular updates on the rain situation.

According to the Central Water Commission's (CWC) flood-monitoring portal, the water level at the Old Railway Bridge crossed the 207-metre mark at 4 am on Wednesday, the first time since 2013. It rose to 208.05 metres at 10 pm and is likely to touch 208.30 by 8 am on Thursday.

Transgender community protests against BJP MLA Nitesh Rane

PUNE: Members of the transgender community on Wednesday staged a protest here against BJP MLA Nitesh Rane over a derogatory word he allegedly used while referring to Shiv Sena (UBT) chief Uddhav Thackeray. The protesters sought the registration of a First Information Report (FIR) against Rane. "Rane used gender, which is our social identity, as a slur in a social media post while criticizing Uddhav Thackeray. We have been demanding the registration of an offense against Rane for his post," said a member of the community. They were sitting outside the Bundgarden police station since Tuesday night seeking an FIR against Rane but on Wednesday the police, instead of acting on their demand, forced them to leave, they alleged. Smartana Patil, Deputy Commissioner of Police (Zone II), said the police initially asked the protesters to make way for a `palkhi' (religious procession).

Angered by student's death, students vandalised Allahabad University

PRAYAGRAJ: Students of Allahabad University on Wednesday scuffled with teachers and vandalised some offices on the campus over the death of a student under 'suspicious circumstances', the varsity said. Some miscreants from outside led by student leader Ajay Yadav Samrat vandalised the university campus and indulged in indecent behaviour and scuffled with women in which some women teachers were injured, a university spokesperson claimed. According to the statement, the miscreants vandalised the Hindi and Sanskrit departments besides damaging some documents at the proctor's office.

Woman killed in explosion at illegal cracker manufacturing unit in Raiasthan

JAIPUR: A 25-year-old woman died in an explosion in her home in Rajasthan's Jhunjhunu district on Wednesday, with police saying crackers were being illegally manufactured there. The victim has been identified as Afreen. She died early on Wednesday in the explosion at her home near Islamia Madrasa in the Udaipurwati area, the police said. The roof of the house was blown away by the impact of the explosion. The woman fell on the roof of another house where she died, they said. Her body was handed over to family members after post-mortem. The police have registered a case against her husband Javed and others under provisions of the Indian Penal Code and the Explosives Act. "Preliminary investigations revealed that firecrackers were being manufactured illegally in the house. Gunpowder was kept in the room where the explosion took place," the police said.


